Privacy Policy

This Privacy Policy describes how Safe Lifting Europe B.V. collects, uses, processes and discloses information. When we refer to "Safe Lifting", we mean the Safe Lifting entity that acts as the controller or processor of your information, as explained in more detail below.

1 Applicability

This Privacy Policy applies to Safe Lifting's website and other interactions (e.g., e-mail) you may have with Safe Lifting. For the use of the Services and processing of any information, files, notes, messages or other content submitted through Services accounts (collectively, "Customer Data") by Safe Lifting.

2 Information Safe Lifting Collects And Receives

Safe Lifting may collect and receive Customer Data and other information and data ("Other Information") in a variety of ways:

2.1. Safe Lifting collects and/or receives

4 Data Retention Other Information

Customer Data is retained and deleted as described in the DPA. The deletion of Customer Data and other use of the Services by Customer may result in the deletion and/or de-identification of certain associated Other Information. Safe Lifting may retain Other Information pertaining to you for as long as necessary for the purposes described in this Privacy Policy. This to conduct audits, comply with (and demonstrate compliance with) legal obligations, resolve disputes and enforce our agreements.

5 How Safe Lifting Discloses Information

5.1. Customer's Instructions.

Safe Lifting will solely share and disclose Customer Data in accordance with Customer's instructions, including any applicable terms in the Terms of Service and Customer's use of Services functionality, and in compliance with applicable law. The Customer exclusively controls the Customer Data and gets to decide what to do with Customer Data.

9. Cookies

Safe Lifting uses Google Analytics to improve the website, Google Analytics uses cookies to achieve this. You may opt out by not allowing cookies upon entering our website or disable them in your browser. Google Analytics collects the following data:

- Device type
- Browser type
- Pages visited
- Amount of time spent on the Safe Lifting website

The following data is not collected:

- User ID
- IP adress

This data is stored on Google servers in the United States of America, Safe Lifting has no influence over this. Google may provide this information to third parties if Google is legally obliged to do so.
